

**MINUTES OF THE REGULAR MEETING  
OF THE BOARD OF COMMISSIONERS FOR LAKEVIEW POLICE DEPARTMENT  
FOR THE CITIES OF TAYLOR LAKE VILLAGE AND EL LAGO, TX  
HELD ON MAY 11, 2020**

**1. CALL TO ORDER:**

Chairman O'Donel called the meeting to order at 6:30 p.m. with the above listed commission members present. The Pledge of Allegiance to the United States of America was recited.

**2. ADOPTION OF MINUTES:**

The minutes of the regular meeting held on April 13, 2020 were approved after a motion from Commissioner O'Donel and a second from Commissioner Delly. Minutes passed with all in favor.

**3. CHAIRMAN AND COMMISSIONS REPORTS:**

Commissioner Delly inquired about the new stop light at Kirby and Old Kirby. Chief Savage indicated it is slowing down the traffic.

**4. MAYORS AND COUNCIL MEMBERS COMMENTS (El Lago and Taylor Lake Village):** None.

**5. CITIZEN'S COMMENTS:**

Sheila Brown voiced concerns about protecting the citizens after a dog was shot and killed last month in El Lago by a resident commissioner. Ms. Brown stated the elementary school was vandalized and has seen a rise in crime in recent months.

Commissioner Delly inquired about the vehicle that was later determined to be stolen and how it got through the border crossing. Detective Nelson advised vehicles are scanned but not checked at the time of crossing.

Chairman O'Donel closed Executive Session at 7:11 p.m. to reopen the Open Meeting.


**7. Authorization – Discussion, Consideration and Possible Action On:**


**8. Adjournment:**
